WORDS FROM OUR WORTHY LECTURER

Long time parish archivist and guide, Brother Ed Long, shared this miraculous account of a Marian apparition:

Feast of the Miraculous Medal

SK Edward J. Long In 1830 in the Motherhouse of the Daughters of Charity on the rue de Bac in Paris, France the Holy Virgin appeared to a novice sister we now call Saint, Catherine Labouré.

This young novice sister was awakened by an angel who appeared as a small child. Views differ as to whether this was her guardian angel or Saint Michael the Archangel. He said to her, "hurry the Holy Virgin is waiting for you in the chapel." There Catherine saw the chapel bathed in brilliant light and the Holy Virgin seated in a chair in the sanctuary, A chair that still stands in the sanctuary to this day.

In this Church approved apparition the Virgin Mary asked Sister Catherine to have a medal struck of a vision she showed her. Around this medal, which today we call the Miraculous Medal (it is less popularly known as the Medal of the Immaculate Conception), are the words, "O Mary Conceived Without Sin, Pray for Us Who Have Recourse to Thee." This was 24 years before the promulgation of the Dogma of the Immaculate Conception by Blessed Pope Pius IX (1846-1878).

On the reverse of this medal is portrayed the Sacred Heart of Jesus and the Immaculate Heart of Mary under the letter M with the cross entwined in it representing the union of Mary with Her Glorious Son's Passion all surrounded by twelve stars that represent the twelve apostles and the twelve tribes of Israel.

Today in this chapel Saint Catherine's incorrupt body lies under the very altar where the Blessed Mother first appeared to her. Also interred in the chapel is the incorrupt body of Saint Louise de Marillac founder of the Daughters of Charity along with the heart of Saint Vincent de Paul the co-founder. His incorrupt body lies in state in the chapel of the Vincentian Fathers quite near the Daughters of Charity Motherhouse at 93 Rue de Sèvres 75007 Paris.

The date of the Miraculous Medal feast is November 27.
