SAFE ENVIRONMENT EMPHASIS

From this date forward, our council will emphasize safe environment compliance with both the **Diocese of Dallas** and the **Knights of Columbus Headquarters**.

To clarify, the Diocese of Dallas requires that Safe Environment Screening procedures are to be used with staff and volunteers who work directly with minors and vulnerable adults. In the upper right corner of the St. Paul Parish website, you can click on the Safe Environment link which will direct you to the training and background check requirements. Worthy Advocate Carey Leslie has agreed to monitor our council compliance with the diocesan requirements. We will make sure that Becky Soto, the Parish Safe Environment Coordinator, has an accurate list of our members in compliance.

The Knights of Columbus requires that the Grand Knight, Program Director, Family Director, Community Director, and Youth Director utilize the Armatus Praesidium (www.praesidiuminc.com) system to keep their qualifications current every two years.

ELECTION OF THE POPE
BY WORTHY LECTURER ED LONG
THE PAPAL CONCLAVE

The Code of Canon Law (Canon 349) states in part that, "the College of electors of the Supreme Pontiff is composed solely of the Cardinals of the Holy Roman Church. In them one finds expressed in a remarkable synthesis the two aspects which characterize the figure and office of the Roman Pontiff: Roman, because identified with the Bishop of the Church in Rome and thus closely linked to the clergy of this City, represented by the Cardinals of the presbyteral [priest], diaconal titles of Rome and to the Cardinal Bishops of the suburbicarian Sees; Pontiff of the universal Church, because called to represent visibly the unseen Pastor who leads his own flock to the pastures of eternal life. The universality of the Church is clearly expressed in the very composition of the College of Cardinals, whose members come from every continent."

Universi Dominici Gregis requires that, "the election of Supreme Pontiff....is to take place exclusively in the Sistine Chapel of the Apostolic Palace of the Vatican." The old way of dividing up large rooms in the Apostolic Palace and placing beds, separated sometimes only by a curtain for privacy, and rudimentary amenities for the cardinals has been replaced by a "hostel" built in the Vatican City-State called Domus Sancta Marthae. Here each cardinal will have his own room chosen by lot and be transported to the Sistine Chapel, some 1000 feet, by bus for voting.

CONCLAVE AND ELECTION

The word conclave comes from the Latin phrase "cum clave" which means "with key." The first pope to be elected by a conclave was Celestine IV (1241-1241). When his predecessor Gregory IX (1227-1241) died the cardinals could not agree on his successor. The people became angry at the delay and locked (cum clave) the cardinals in their meeting place, the Septizonium Palace, until they had elected someone! This only occurred after several weeks of voting in the heat of Rome with poor or no hygiene and absolutely no one allowed to leave or enter the conclave. One cardinal died and several of them became very ill. Finally Celestine was elected, and, weak from the long ordeal, died seventeen days later. Today with a few more amenities papal elections are held in the strictest of secrecy. The cardinal electors are sealed within the Apostolic Palace, windows and doors sealed over with brick and the only door not bricked up locked and sealed with a wax seal. The "key" to getting out is electing a pope.

The Apostolic Constitution *Universi Dominici Gregis* lays out in detail the procedure for electing the Sovereign Pontiff. The Cardinal Electors take part in the solemn Mass "For the Election of a Pope." Following the Mass they process, in choir dress: scarlet cassock, white rochet, scarlet cape and the symbol of the cardinals power to vote for pope, the scarlet biretta, to the Sistine Chapel chanting the Veni Creator, where voting and election will take place.

Prior to *Universi Dominici Gregis*, there were three valid methods of election. A man could be elected by acclamation of the cardinals by inspiration of the Holy Spirit (to see an example of this watch the movie "The Shoes of the Fisherman"). He could be elected by compromise among the Cardinal Electors. And lastly, he could be elected by secret ballot. In this conclave there is only one valid method of election, that

by secret ballot. For election as pope a man must receive two-thirds of the votes of those Cardinal Electors present. There can be one vote on the first day if time permits. The regular schedule is for four ballots per day. Two in the morning session and two in the afternoon session. After each session, if no one is elected, the ballot sheets from both ballots are strung together placed in the famous Sistine Chapel stove (which is only installed during Conclave) with wet straw (or, more recently, with a black smoke flare) and burned. Black smoke signals to the crowd and the world that no election has taken place. To signal election to the outside world the ballots and all notes are burned with dry straw (today a white smoke flare) with the white smoke signaling election.

When a man receives votes sufficient for election it is a time of great joy in conclave. The Cardinal Dean (the senior cardinal) will approach the one elected and ask if he accepts election. At the moment he accepts his election, he is pope. No inauguration or installation is needed. Following his designation of the name he will be called, the conclave is over. What follows is the announcement by the Cardinal Dean from the central loggia of St. Peters, "Habamus Papam," "we have a pope" and the new popes first blessing Urbi et Orbi, to the City and to the world.

On 26 June 2007 Pope Benedict XVI decreed in a *motu proprio* that the next pope must receive two-thirds majority in conclave in order to be elected. The new decree requires that after 13 days without election the cardinals will pause for prayer, dialogue, and reflection for a day and then proceed to a runoff election between the two cardinals who received the most votes on the previous ballot. These two leading cardinals would not vote in the runoff ballots but would remain in the Sistine Chapel.
