Another example is the Renew/Why Catholic movement whereby individuals once gathered weekly to learn more about the faith and what they could do to support each other. Several of these groups still come together long after the programs that spawned them ceased.

Since this is a new initiative, we need to listen for now to how the Order directs us to accomplish this. We also need to consider the ways our council might want to engage in this ministry.

And, as we enter this second half of the fraternal year, let us pray for the continued vibrancy of our council and for a smooth transition to a strong slate of officers for the next fraternal year.
